Pet Policy

We look forward to providing a wonderful stay for you and your pet. To ensure the comfort and enjoyment of all our guests, the following policies apply to your pet's stay:

- 1) There is a \$75.00 plus tax charge per reservation. The fee will be charged to your account prior to check-out to cover the cost of deep-cleaning the room in preparation for our next guest.
- 2) Pets must be leashed throughout all common areas of the hotel and are prohibited from entering The Blue Hen or Morrissey's.
- 3) We reserve the right to refuse to accommodate or require immediate removal of any pet that displays behavior deemed dangerous or unacceptable, in our sole opinion, including, but not limited to; biting, excessive barking, evidence of disease, or urination or defecation in public areas. You will be responsible for all charges relating to the removal of your pet including kennel charges.
- 4) You will be billed for any additional cleaning bills or repairs should they be required and authorize the hotel to charge your credit card for such charges, even if they are discovered following your departure from the hotel.
- 5) You must be present, remove or crate your dog while any member of the hotel staff, such as housekeeping or engineering, is in the room and acknowledge that housekeeping and/or engineering will not service your room unless you are present or have your dog crated while you are away.
- 6) You are responsible for cleaning up after your pet on the property of The Adelphi Hotel.

Indemnification and Release

In consideration of The Adelphi Hotel allowing my pet to stay, I understand and voluntarily agree that I will be solely responsible for my pet and for any loss, damages, personal injuries, including death, sustained by my pet.

I Release and Agree to Hold Harmless, Indemnify and Defend the owners of The Adelphi Hotel from any and all claims,

lawsuits, actions, debts, bills, judgments, arising from or related to my pet's presence at The Adelphi Hotel.

_____ In the event that I choose to place the care of my pet under the supervision of hotel staff, I understand and voluntarily agree that I will hold harmless The Adelphi Hotel, its owners and staff members, should any incident occur, on or off property, in which harm comes to my pet, up to and including death. I will be solely responsible for any loss or damages caused by my pet while under the supervision of hotel staff. Payment for any such services will be decided on a case-by-case manner between myself and the individual staff member(s).
